Much higher speed to access the internet is a great benefit to businesses, residents working from home, or just for watching the likes of BBC iPlayer which allows free access to just about every TV programme on BBC of the previous week. A further great benefit is that no street in our mediaval grid has to be dug up, with all that is required being an extra street cabinet, alongside or close to existing BT cabinets. A new application is now being made by BT for a box in Churchgate Street, after the intervention of our MP David Ruffley and we ask that all residents think very carefully before objecting to something which brings such huge benefits to so many businesses and residents in our area. If you are not happy about the proposal when it comes out, please do contact Stephen Mills our planning representative on 01284 754366 or myself on 01284 762552 so we can go over your concerns in detail. This is now the very last chance to get super-fast broadband (several times faster than what we have now) and many residents and businesses will be prevented permanently from getting access if the planning application for the box is refused. - Andrew Hinchley (Chairman)

## Licensing: Queen's Head

Many residents will be aware that the Queens Head in Churchgate Street was granted the full extra hours requested, including up to 2am at weekends at a recent Licensing hearing. Many CAA members had been in contact with the CAA voicing concern on the proposed extension and the CAA alongside many residents did formally object to the St Edmundsbury Licencing authority. However at the hearing two councillors voted for the extension and one against, so the extension was granted in full.

The CAA had previously held several meetings with the Queens Head to try and get them to reconsider applying for an extension but to no avail. Although residents' concerns were not upheld by councillors, it is important that residents do put their views to the Council on applications, turn up at the hearings in person, and are not put off by having their name published. - David Bonnett (Licencing) and Andrew Hinchley (Chairman)
